1 Introduction

The Trustee Board is responsible for maintenance of this scheme

What a publication scheme is and why it has been developed:

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme will either be available on our website when this online or in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2 Aims

- To make Caroline Chisholm School a successful 4 -18 establishment which challenges the barriers between primary and secondary education
- To extend learning to all age groups
- To make business and enterprise key features of the curriculum
- To create a setting in which sports, the arts, reading and leisure activities contribute to a thriving community
- To bring together the services and companies which contribute to the Centre for Learning and create a single partnership Caroline Chisholm School Education Trust (CCET) The Wooldale Centre for Learning, Wootton Fields, Northampton DfE Number 941/4005
- To establish an ethos of tolerance, kindness and honesty throughout the school.

This publication scheme is a means of showing how we are pursuing these aims.

3 Categories of information published

The classes of information that we undertake to make available are organised into four broad topic areas:
